At the outset of the meeting the Chairman welcomed the members of the Committee after that the following agenda items were taken up.

BWC-54/18/01: To confirm the minutes of the last (53rd) meeting.

The minutes of the 53rd meeting of the B&WC were circulated among all members and no comment was received. The minutes were confirmed and recommended to FC.

BWC-54/18/02: To take note on action taken and progress made on the resolution of the 53rd meeting held on 25.09.2018.

The B&WC noted the action taken report.

BWC-54/18/03: To consider estimate for extension of Vehicle Garage at Gr.III Colony.

The committee discussed the proposal submitted by CPWD at an amount of Rs. 23,95,000.00 & recommended the same to FC & BOG for approval. However, the execution should be carried out after getting clearance from the MHRD.

BWC-54/18/04: To consider award of work of vertical extension of Girls Hostel No. 3.

The committee discussed the matter and noted that the CPWD did not agree to execute this work citing the reason that original construction was not done by the CPWD. The committee accepted the Bid Evaluation report & recommended the same to FC & BOG for award of work to L-1 agency.

BWC-54/18/05: To consider the Estimate for supply, installation testing and commissioning of one no. 13 passenger capacity lift at Library building at NIT Silchar.

The committee recommended the proposal to FC & BOG. However, the execution should be carried out after getting clearance from the MHRD.

BWC-54/18/06: To report about the action of CPWD in respect to Internal Road work at NIT Silchar.

The committee noted the same & requested the Institute to pursue the same with the CPWD.
