Minutes of the Fifty-eighth (58th) Meeting of the Senate held on 10th Dec 2018

The Fifty-eighth (58th) meeting of the Senate was held on 10 Dec 2018 at 10:00 AM in the Conference Hall of the Institute. The following members were present:

At the outset, the Chairman, Senate welcomed all members and initiated discussion on the agenda items. The following decisions were taken.

### S-58/18/1 To consider confirmation of the minutes of the 57<sup>th</sup> meeting of the Senate held on 12 July 2018

The Senate confirmed the minutes.

### S-58/18/2 To consider actions taken on the decisions adopted in the 57<sup>th</sup> meetings of the Senate

The Senate noted the action taken report.

#### S-58/18/3 To consider proposed new B.Tech. Regulations to be effective from 2018-19 batch onwards

After a detailed deliberations on the committee recommended Regulations, the Senate accepted the same with following modifications:

• Clause 2 (Semester: odd and Even): be modified to:

"The Institute follows a credit based semester system. There are two regular semesters in a year: odd semester (July-November) and even semester (January-May). In additional to these, the Institute also runs an additional semester during the summer vacation, known as summer semester (May-June) to offer summer courses. A faculty can offer at the most two courses (including lab course) only in summer semester. The objective for the summer semester is to facilitate the students to clear backlog courses, if

any. Only backlog subjects arising out of regular course registration is permissible to register in the summer semester as regular course registration."

- Clause 6.3: the credit requirement shall be 200
- Clause 6.12: the last sentence be substituted by "The concerned DUPC/CEC (Course Equivalence Committee) constituted by the Senate shall establish the adequacy of the education so received in another institution. The DUPC/CEC recommendations shall be placed before the Senate for consideration and approval"
- Clause 8.1: following lines shall be added:
   "However, under exceptional situations, A committee comprising of the Chairman, Senate, Dean (Academic), and the concerned Head of the department may consider condoning of the required attendance."
- Clause 11.2: Typographical mistake clause 10.1 shall be read as clause 11.1
- Clause 19.3: the table shall be replaced by the following table:

Clause 26.2: the first sentence shall be replaced by the following:
 "On the recommendation of the DUPC and with the approval from the Dean (Academic), a student may register courses under MOOCs/online/other platforms in the sixth, seventh, and eighth semesters with a maximum of 24 weeks contact hours per semester"

Clause 27: Typographical mistake clause 20.5 shall be read as clause 24.5
 However, one of the members, Prof. B. K. Roy expressed his dissent on the absolute grading pattern of the Regulations.

Further, the Senate agreed to make this Regulations applicable with effect from 2018-19 batch onwards. However, it is observed that this Regulations could not be made available at the time of admission of 2018-19 batch. Accordingly, the Senate permitted this batch (2018-19 entry) only to appear reexaminations (Dec. 2018-Jan. 2019) for their first semester subjects as a onetime concession.

The Senate decided to recommend the same, with these corrections, to the BOG for kind consideration and approval.

S-58/18/4 To consider credit transfer policy under ERASMUS+ student Exchange Program

The members agreed to implement the ERASMUS+ exchange Program. The policy for credit transfer shall be as follows:

The concerned DUPC/CEC constituted by the Senate is authorized to recommend mapping of courses (available equivalent courses in terms of content and credit as per our system) of the Institute/University where they are sent. The DUPC/CEC recommendations shall be placed before the Senate for

consideration and approval. The grade earned with such equivalent credit shall be transferred and used for SPI/CPI calculations in all respects.

S-58/18/5 To consider the proposal of MHRD regarding online Degree Programs

The members discussed the content of the communication from the MHRD Secretary (DO No. 18-19/2018-DL dated 6 Nov. 2018) and opined that online degree award by NIT Silchar at this stage is not feasible. However, the Institute will explore to start online programme in near future.

S-58/18/6 To ratify the approval of the Chairman, Senate in respect of extension of study period

(F) The Senate noted the approval accorded by the Chairman, Senate in respect of the revised B.Tech. (first year) Syllabi submitted by the concerned departments, to be effective from 2018 entry batches.

Further, the Senate also noted the 3 digit subject code used for the new curriculum to distinguish the courses from the old one.

# S-58/18/9 To consider the distribution of Research Scholars (under MHRD fellowship)

The Senate discussed the matter at length and decided that number of Ph.D. scholars (with MHRD fellowship) be distributed among the faculty members as 5, 4, 3 to Professor, Assoc. Professor, and Asst. Professor, respectively.

The Senate after detailed discussion on the matter decided that the Ph.D. scholars under sponsored project be considered in category 'Regular' under Group-B as per recent advertisement.

S-58/18/9 Change of nomenclature in case of two Supervisors

The Senate noted the Clause 7.1 (b) of the old Ph.D. regulation, which states that "The student may have a second supervisor from the same department or from another department. In this case each of the supervisors will be called as a Co-Supervisor" But this creates a confusion in regards to Supervisor and Co-Supervisor.

In view of this, the Senate decided to follow the designations of the new Regulations made effective from July, 2014 batch.

S-58/18/9 To consider Ph.D. course work of temporary faculty members engaged through TEQIP-III

As per NPIU letter no. NPIU/TEQIP-III/442 dated 5 June 2018, the temporary faculty members engaged through TEQIP-III may be admitted to part-time Ph.D. program at the nearest NIT. However, for such students the course requirement is to be fulfilled by taking online courses such as MOOCs, Swayam courses approved by the concerned Supervisor/Departmental Research Evaluation Committee. But, the Course work evaluation of these courses is to be done at the concerned NIT, through their routine examination process, for which the candidate has to visit the concerned NIT. PhD regulation norms applicable for these faculty may be at par that for the internal faculty.

After discussion, the Senate authorized the Chairman, Senate to constitute a committee to study the matter and make a suitable recommendation.

The meeting ended with a vote of thanks to the Chair.
