Minutes of Fifty-ninth (59th) Meeting of the Senate held on 17 June 2019

At the outset, the Chairman, Senate welcomed all members and initiated discussion on the agenda items. The following decisions were taken.

S-59/19/1: To consider confirmation of the minutes of the 58th meeting of the Senate held on 10 December 2018.

The Senate noted the minutes and after deliberations on the comments received, the minutes were confirmed without any amendment, except the word 'his' under S-58/18/7 be replaced by 'his/her'.

S-59/19/2: To consider actions taken on the decisions adopted in the 58th meetings of the Senate

The action taken report was noted by the Senate.

S-59/19/3: To consider introduction of a new subject to the pool of Open Elective I of the B.Tech. Curriculum of EE department

The proposed subject EE 1478: Biomedical Signal Processing & Control, along with the syllabus, was approved as a subject under Open Elective I of B.Tech. curriculum (pre-revised) of the EE department. However, the Senate desired that the minimum contact hour be 40 hours. Accordingly, the contact hours be modified by the DUPC and the revised version be submitted to the academic section.

S-59/19/4: To consider new M.Tech., M.Sc., and MBA Ordinances and Regulations

The members opined that the time was very short to go through the proposed amended Ordinances and Regulations. But, an early decision was needed for their implementation w.e.f. from 2019 entry batches. In view of this, all the members were requested to go through the same and forward their comments to the Dean, Academic, who is also the Chairman for the committees constituted to recommend revised rules, within seven days. The concerned committees were requested to review their recommendations after consulting the comments, and submit revised versions to the Chairman, Senate. The Senate further authorized the Chairman, Senate to recommend the same to the BOG for approval so that the new Ordinances and Regulations can be put in place wef 2019 entry batches.

S-59/19/5: To consider 2019-20 academic calendar

The proposed Academic Calendar 2019-20 was approved with few minor corrections. The finalized academic calendar is as enclosed in **Annexure I**. However, in view of the first semester students joining late, the Dean (Academic) was requested to explore the possibility to delay their mid-sem exams in the odd semester.

S-59/19/6: To consider issues related to incorporation of the subject NCC (EAA course) in the first year grade card

As per new B.Tech. curriculum, NCC is one of the compulsory but non-credit courses offered in either the first or second semester. But, the NCC authority normally does not evaluate them in the initial period (first semester); and hence, their PP/NP grade cannot be reflected in the semester grade card.

In view of this, the Senate decided to constitute the following committee to frame an evaluation mechanism for grading all the EAA courses, except YOGA:

3. Mr. Suraj Singh, Sports Officer : member

The Senate further decided to evaluate the last batch of students applying the same mechanism and reflect their grade in the subsequent semester grade cards.

S-59/19/7: To consider request from the 3rd and 4th year B. Tech. students to conduct a special exam

The Senate decided that a special exam be conducted only for the outgoing B.Tech. students (2015 & prior batches). The exact duration (dates) and modalities shall be decided by the Dean (Academic). For this special exam, the eligible student can register for a maximum of 6 backlog subjects. However, the maximum ceiling for grading will be BB Grade

S-59/19/8: To consider difficulty in issuing duplicate certificate/grade card where the original was sent by post but not received by the students

The Senate resolved that the matter is purely administrative in nature and should be dealt with accordingly.

S-59/19/9: To ratify the approval of Chairman, Senate in respect of shifting the subject EE 1485: Computer Organization & Architecture from the pool of Open Elective II to the pool of departmental Elective IV

The Senate ratified the approval of Chairman, Senate in respect of shifting the subject EE 1485: Computer Organization & Architecture from the pool of Open Elective II to the pool of Departmental Elective IV.

S-59/19/10: To ratify the action of the Chairman, Senate in respect of allowing preponment of re-exam for the B.Tech. (8th semester) subject of last concluded end-sem exam

The Senate ratified the action of the Chairman, Senate in respect of allowing preponment of re-exam for the B.Tech. (8th semester) subjects of the last concluded end-sem exam.

S-59/19/18: Any other item from the Chair

(A) To consider B.Tech. curriculum (3rd-8th semesters) along with syllabi wef 2018 entry batch

The agenda item was discussed on the table and the Chairman, Senate requested the Head of all departments to submit the curriculum (3rd-8th semesters) along with the syllabi at the earliest. The Senate noted the urgency as the classes for next third semester shall start during the next July. In view of this, the Senate authorized Chairman, Senate to approve the curriculum with the syllabi for 3rd semester B.Tech.

(B) To reconsider the distribution of Research Scholar (with MHRD fellowship) among the faculty members

The Senate discussed the matter and decided that the distribution of Ph.D. Scholars (with MHRD fellowship) among the faculty members will remain as 5, 4, and 3 to Professor, Associate Professor, and Assistant Professor, respectively.

However, the Senate authorized the Chairman, Senate to allot MHRD Scholar to faculty members on case to case basis on the recommendation of the concerned DPMC.

(C) To Consider Coursework for Ph.D. students admitted under TEQIP-III

The Senate allowed to carry out the Ph.D. course work of the temporary faculty members engaged under TEQIP-III by taking the online course such as MOOCs/Swayam courses. The subjects for the online course work are to be decided by the DC/DPMC of the concerned student as in other cases.

They have to appear the examination for course work(s) at NIT Silchar along with the other Ph.D. Scholars. However, separate question paper is to be set as per the syllabi of the online course work allotted to them by the DC/DPMC of the concerned department.


