NATIONAL INSTITUTE OF TECHNOLOGY SILCHAR MINUTES OF THE 60TH MEETING OF BUILDING & WORKS COMMITTEE HELD ON 30.09.2019

The 60^{th} Building & Works Committee meeting was held on 30.09.2019 at 10.00 AM in the NIT Transit House, New Delhi. The meeting was chaired by Prof. Sivaji Bandyopadhyay, Chairman, B&WC and attended by the following members:

At the outset of the meeting the Chairman welcomed the members of the Committee and the following agenda items were taken up.

BWC-60/19/01: To confirm the minutes of the 59th B&WC meeting.

The minutes of the 59^{th} meeting of the B&WC were circulated among all members and no comment was received. The minutes were confirmed and recommended to FC.

BWC-60/19/02: To take note on action taken and progress made on the resolution of the 59th meeting held on 24.07.2019.

The B&WC noted the action taken report.

BWC-60/19/03: To consider the detailed report about the Sports Complex & Auditorium Building.

The issue was discussed in details starting from inception of the project and subsequent merger of Auditorium Building with Sports Complex. It was observed by B&WC that prior approval was accorded by competent authority at all stages of works. PMU committee after physical verification of the projects and after noting the various committee reports recommended the execution of some balance works to ensure the effective utilization of Sports Complex and Auditorium.

B&WC also observed that total approved amount for the project is Rs. 52.94 Crore and total executed amount is Rs. 49.50 Crore. Thus B&WC considered the proposal for carrying out levelling and providing drainage in the cricket and football fields, construction of athletic track field and completion of entrance gate to stadiums at an estimated cost of Rs. 1,15,68,847/- and recommend the same to FC and BOG for approval.
