Minutes of Sixty-first (61st) Meeting of the Senate

At the outset, the Chairman, Senate welcomed all members and initiated discussion on the agenda items. The following resolutions were taken.

S-61/19/1: To consider confirmation of the minutes of the 59th meeting and 60th emergent meeting of the Senate held on 17/06/2019 and 31/07/2019 respectively

The Senate noted the minutes and after deliberations on the comments received, the minutes were confirmed with following amendments:

- S-59/19/11: The following sentence be added at the last:

 The course content of EC 1486 needs to be reviewed by an expert committee.
- S-59/19/18(A): The last sentence be substituted by, "In view of this, the Senate authorized the Chairman, Senate to approve the curriculum with the syllabi for 3rd sem B.Tech.



- S-59/19/18(B): The last part be substituted by, "However, the Senate authorized the Chairman, Senate to allot MHRD scholar to faculty members on case to case basis on the recommendation of the concerned DPMC.
- S-59/19/18(C): In the first sentence, "of NIT Silchar" be deleted.
- S-61/19/2: To consider actions taken on the decisions adopted in the 59th and 60th meetings of the Senate

The Senate noted the actions taken on decisions in its 59th and 60th meetings.

S-61/19/3: To consider and recommend awarding degrees to all the graduating students (B.Tech., M.Tech., M.Sc., MBA, and Ph.D.) who have qualified for the same after the last convocation

The Senate noted the results of the lists of students who have successfully fulfilled the requirements for the respective degrees of the Institute. Total numbers of degree recipients in various Programmes are as follows:

S-61/19/5: To consider introduction of Best All Round Graduate Award

The Senate noted that presently a sponsored "best engineering graduate award (Kalikrishna-Mrinalini Krori Award)" is conferred at every convocation. However, the Institute of its own does not confer any such award. In view of this, the Senate decided to recommend to BOG introduction of a "Best All Round Graduate award" in the form of gold-plated silver medal, with effect from the XVII convocation. The degree (B.Tech.) recipients at a given convocation shall be eligible for the award. The recommended selection criteria for ensuing convocation (XVII) are as follows:

S-61/19/6: To consider introduction of Best Doctoral Award for Ph.D. degree recipients

The Senate noted that as of now the Institute does not confer any award to recognize and encourage outstanding research (Ph.D.) work. Therefore, the Senate decided to recommend to BOG to introduce a 'Best Doctoral Award" in the form of gold-plated silver, with effect from the XVII convocation. All the Ph.D. degree recipients at a given convocation shall be eligible for this award. The selection criteria to be followed for the ensuing convocation (XVII) are as follows:

(B) To consider allotment of seats to the Ph.D. programs (Engineering Department) under Study in India (SII) scheme

The Senate noted that the Institute has already joined the Study in India (SII) program with 28 and 22 seats in M.Tech. and B.Tech. programs, respectively. The Senate also noted that so far as tuition fee is concerned, this scheme has various group of students (G1, G2, G3, G4), with tuition fee waivers of 100%, 50%, 25%, and 0%, respectively.

After a detailed discussion, the Senate in principle decided to recommend an intake of 2 seats per Engineering department in Ph.D. program under this Scheme, in addition to the existing 50 seats in UG and PG programs for admission with effect from 2020 batch.

The Senate, further, observed that the tuition fee charged for the SII scheme is same as that of the DASA scheme, even though the targeted counties of the SII scheme are economically not very sound. In view of this, it was decided that the tuition fee charged for this scheme be reviewed by the Institute.

(C) To take a note on the punishment awarded to 02 students for adoption of unfair means in examination.

(D) To ratify the new curriculum with syllabi of the PG Programs with effect from 2019 entry batch

As authorized (S-59/19/4), the new Ordinances and Regulations for all the PG programs (M.Tech., M.Sc., and MBA) were reviewed by the concerned committees and approved by the competent authority. The same were implemented with effect from 2019 entry batch. As demanded by the new Regulations, new curricula were needed. Accordingly, the new curricula with syllabi (first semester only) received from the concerned departments were implemented with approval of the Chairman, Senate. It may further be mentioned that there has been some modifications in the coding scheme/numbers for the subjects. The copy of the same signed by the Chairman, Senate is enclosed in Annexure I.
