The BoG then initiated the discussion on the Agenda Items one by one: -

BoG-62/18/01: Faculty Recruitment.

Institute vide No. NITS/Estt/Faculty/Advt/17 dated 24.10.2017 advertised for various faculty positions. The recruitment process of following Departments are over.

- 1. Department of Mechanical Engineering
- 2. Department of Mathmatics
- 3. Department of Physics
- 4. Department of Chemistry

As per clause 24(a) of NIT Act 2007 as amended from time to time appointment of academic staff in the post of Lecturer (5th CPC) or above is to be made by Board.

Further, the Board decided to issue the offer of appointment as per the 7th CPC pay scale and cadre structure.
