At the outset of the meeting the Chairman welcomed the members of the Committee and the following agenda item was taken up.

BWC-63/21/01: To Construct the Girls Hostel No.4 at NIT Silchar.

The committee discussed the matter in details and agreed in principle to construct the proposed Girls Hostel-4 with 600 capacity. However, it is also resolved to carry out the said construction in three phases.

In 1st phase, Girls Hostel No. 4 (A) with a capacity of 150 students on an estimated cost of Rs. 25,96,49,211.00 from the EWS fund (as allocated by the then MHRD vide letter no. F.No.35-4/2019-TS.III dated 19.06.2019).

In 2nd phase, Girls Hostel No. 4 (B) with a capacity of 150 students on an estimated cost of Rs. 25,96,49,211.00 from the IRG head.

In 3rd phase, Girls Hostel No. 4 (C) with a capacity of 300 students to be constructed and the proposal of the same is to be forwarded to the Ministry of Education, New Delhi for adding it to the budget of the next financial year. The committee requested the Dean (P&D) for preparation of DPAR for further needful.

The DPAR of GH- 4(A) and GH- 4(B) with an estimated cost of Rs. 25,96,49,211.00 eachwas tabled in the meeting with the permission of the Chair and was duly approved and forwarded by the Committee to be placed in the next FC & BOG.

The minutes of the 63rdemergent meeting of the B&WC was further confirmed on table.

The meeting ended with a vote of thanks to the chair.
