FC-27/13/02 To take note of the action taken report and progress made on the Minutes of the last meeting of the committee.

The committee noted the action taken on the resolution of the last meeting.

FC- 27/13/03: To ratify the action taken by the Director in adopting Audit Report received from Director General of Audit, Kolkata, on the Accounts of NIT Silchar for the year 2012-13.

The Institute has received Audit Report from the Director General of Audit, Kolkata on the Account of NIT Silchar for the year 2012-13 on 06th Nov. 2013. Considering the importance, this was sent to MHRD, on obtaining approval from the Chairman BOG, NIT Silchar, to place before Parliament along with Annual Report 2012-13.

The committee took note of the action taken with the approval of the Chairman by the Director.

The Finance Committee took note of the financial status and appealed to MHRD to release funds under plan head to enable the Institute to complete the ongoing projects.

FC -27/13/05:

To take note of the investment procedure followed by the Institute in respect of Provident Funds, Superannuation Funds and Gratuity Funds.

Institute is having an investment committee consist of 3 members from various fields to look after the investment matter quarterly, related to Provident Funds, Superannuation Funds, Gratuity Funds and other Funds. This institute has full fledged branch of State Bank of India in its campus and all the investments are made in Nationalized Banks only to avoid risk factor on investment and to fetch guaranteed & higher rate of return on investment, as the money pertains to provident fund, Superannuation fund and gratuity fund of the employees of the Institute.

During last audit for the financial year 2012-13, Audit has raised observation on non-compliance investment procedure notified by the Ministry of Finance on 14th August, 2008. According to notification said fund to be invested as follows:

- (i) Govt. Security/Other Security/Mutual Fund upto 55%
- (ii) Debt Security/Scheduled Commercial Bank upto 40%
- (iii) Money market instrument incl. mutual fund upto 05%
- (iv) Shares of Companies available in BSE/NSE upto 15%

But due to remoteness of the area and to avoid risk factor as stated above, Institute is not following the above guidelines notified by the Ministry.

The committee recommended the investment procedure in vogue which is free from any market risk to the B.O.G for approval.

FC -27/13/06:

To consider outsourcing of the job for conducting physical Stock verification and creation of Fixed Asset Register of the Institute.

A thorough physical verification of the movable and immovable assets of the Institute is required to be conducted and a fixed asset register containing all this properties is required to be created at the earliest. This has also been pointed out by the Govt. Audit during their last Audit. In view of the above, it is proposed that the job for conducting physical verification and creation of fixed asset register may be outsourced as it involves not only huge volume of work but also expertise.

The committee recommended the proposal to the BOG for approval.

FC -27/13/07:

To consider outsourcing of the job for conducting data entry by splitting the fund value of Contributory Provident Fund Account in to Pension Corpus fund and G.P. Fund.

Due to implementation of Pension cum GPF in the Institute, accumulated amounts lying in C P Fund of around 350 employees are to be split into in two part i.e. Pension corpus fund and G. P. Fund, those who are covered under CCS Pension rule 1972. This work is required to be completed within the current financial year. In view of the above it is proposed to outsource the job considering the huge volume of work.

The committee recommended the proposal to the BOG for approval.

FC-27/13/08:

To consider the issue of allowing Special duty allowance to the staff members of NIT Silchar during the period of leave/ Vacation.

As per the provisions of FR, special duty allowance (SDA) is authorized to Central Govt. Employees serving in North East Region. However, this is not admissible during leave/ training beyond 15(fifteen) days at a time and 30(thirty) days in a year. This is an incentive to motivate people to serve in the North Eastern Region where the communication facility is exceptionally bad due to lack of proper roads and rail heads.

The Finance Committee is requested to waive this provision restricting non-payment of SDA to staff members of this Institute to attract talent.

The committee especially the members representing the MHRD felt that the proviso of FR cannot be changed without the approval of Min. of Finance, (Dept of Expenditure). It was decided to refer the matter to Min. of Finance through MHRD.

FC-27/13/09:

To ratify the action taken by the Director for transferring Rs.15.00 crores from Institute Corpus Fund, Maintenance Fund and Depreciation Fund (@ Rs.5.00 crore from each Fund) to Institute Plan Fund.

Due to non-receipt of Grants-in-Aid towards Plan Activity from the Govt. for 2nd quarter, Institute is facing acute financial crisis to continue the ongoing project. In this regard several communications have been made with the Ministry for release of Grants. To run the ongoing projects smoothly, it was decided to transfer Rs.15.00 crores from Institute Corpus Fund, Maintenance Fund and Depreciation Fund (@ Rs.5.00 crore from each Fund) to Institute Plan Fund as a temporary measure, which will be refunded to the respective funds immediately on receipt of Grants from the Govt.

The committee ratified the action taken by the Director.

The finance committee examined the minutes of 37th B&WC and the recommendation on each agenda item of the B&WC is given as follows.

FC-27/13/10(a):

To consider proposal and preliminary (Plinth Area) estimate for proposed construction of 1000 capacity Boys Hostel No. 10 at NIT Silchar.

(BWC-37/13/03)

The Institute is planning to increase undergraduate intake capacity by 1000 before 2015. The existing students accommodation available in 10 Hostels (Boys & Girls) is 2388. Another 1000 capacity Boys Hostel No.9 is under construction. Keeping in view of further increase in undergraduate intake capacity by 2015, the additional requirement of students accommodation will be as follows:

Existing Hostel	capacity	Cumulative capacity
Boys Hostel 8 Nos. Plus Girls Hostel 2 Nos.	2388	2388
Boys Hostel No.9 (under construction)	1000	3388
Another Hostel of 1000 capacity (proposed)	1000	4388

To cater to the requirement of additional student's accommodation, the Institute is planning to construct another Boys Hostel No.10 of 1000 capacity. On this back drop the Institute has prepared a preliminary (Plinth Area) estimate based on CPWD Plinth Area Rates effective from 01.10.2012 covering all relevant provisions like Civil & Electrical works, water supply, sanitary works, fire alarming and fire fighting, internal road, networking system, landscaping, standby power breakup provision etc. The preliminary estimated cost arrived at is Rs.91,53,00,293.00 including 3% contingencies and considering current enhancement in cost since 01.10.2012.

The proposal & preliminary estimate (Plinth Area) was placed before the 37th B&WC meeting under item No. BWC-37/13/03 and recommended for the examination of the Finance Committee.

The Finance Committee after examining the proposal recommend the same to the BOG for approval.

(BWC-37/13/05)

Assam type Amenities building and RCC type single storey Mechanical Engineering Workshop building (north & south block) were constructed by Assam PWD in the year 1978.

Initially the Assam type Amenities building having plinth area of 1739 sqm was used for academic purpose. With the passage of time many academic buildings has came up and the said building is centrally located occupying large area is now unserviceable for academic purpose.

RCC type single storey Mechanical Workshop building, centrally located and having 2588 sqm plinth area (ground floor only) now needs to be modified into multi storey buildings in view of acute land scarcity and expansion in academic activities.

A team of experts comprising Architect & Structural Engineer from VNIT, Nagpur have paid visit in 2 occasions to assess the feasibility for vertical expansion of the existing Assam type Amenities building & Mechanical Engineering Workshops. The experts after soil investigation and detailed study expressed their views about the possibility

of vertical expansion. Subsequently, the VNIT, Nagpur submitted the concept plans for modification of said buildings. The Building & works Committee in its 36th meeting under item No. BWC-36/13/13/E2 has decided to entrust the consultancy services of the said projects to VNIT, Nagpur.

The VNIT Nagpur has confirmed that the detailed estimates & drawing will be submitted within the 1st week of December, 2013. The detailed estimate and drawing for modification of (1) Old Assam type Amenities building & (2) Mechanical Engineering Workshops will be placed before the meeting for examination and approval etc.

Proposal & detailed estimate for both the projects will be placed before the 37^{th} B&WC meeting under item No. BWC-37/13/05 for approval etc.

The Committee may examine the resolution of B&WC and may recommend the same to Board for suitable decision.

The Committee recommended the proposal for approval of the BOG.

The Institute is planning to execute different upcoming projects on priority basis and availability of fund through (1) Hindustan Steelworks Construction Ltd. and (2) Hindustan Prefab Limited a Govt. of India Undertaking.

Construction of 300-capacitiy PG Hostel, and 100-capcity Married Scholars Hostel are already entrusted to Hindustan Prefab Limited. The performance of the agency so far is found to be very much satisfactory.

The detailed estimate for both the works will be placed before 37th B&WC meeting under item No. BWC-37/13/09.

The Committee may examine the resolution of B&WC and recommend the same to Board for suitable decision.

The Committee examined the proposal and after detailed discussions decided that either open tender can be invited or Public Sector Undertakings engaged in the field can be asked to submit their offers based on priority.

(BWC-37/13/10)

The campus of the Institute is spread over an area of 1643 bighas having beautiful lakes, set amidst a sprawling landscape of natural quietness, bordered by expansive tea gardens. It presents a spectacle of harmony in modern architecture, natural beauty and picturesque surroundings.

The Institute is planning for further improvement and beautification of the lakes in phased manner. To start the activity it is proposed that initially 3 lakes may be taken up and accordingly tentative cost for beautification comprising of landscape improvement, boat club, internal path, artistic works, fountain etc. have been worked out as given in Table-11.

The detailed estimate for both the works was placed before 37th B&WC meeting under item No. BWC-37/13/10 and recommended for approval of Finance Committee.

The committee felt that the job can be done by PPP (Public Private Participation) through a lease of three to five years instead of spending such huge amounts. These lakes may be used to generate some annual revenue by leasing out to developers who can develop the lake and use it for pisciculture.

However, the committee has agreed to the proposal at SI No. 3 as an experiment and recommend for approval of the BOG.

FC-27/13/10(i):

(1) To ratify the action of Chairman, B&WC for inclusion of additional contractors in the approved panel and (2) accord approval for empanelment of new contractor under Civil category applied for the same.

(BWC-37/13/13)

Building & Works Committee in its 24th meeting under item No. BWC-34/13/16 has approved the empanelment of 33 contractors under civil category and 12 contractors under electrical category for execution of minor civil works up to 10.00 lakhs and electrical works up to 5.00 lakhs.

Subsequently, 8 contractors under civil category applied for empanelment along with relevant documents. The Chairman, B&WC has approved the inclusion of 8 contractors in the approved panel subject to ratification by the B&WC. The details of the same are given in Table-14.
