This is regarding Pre-qualifiers submitted by **National Institute of Technology Silchar, Cachar, Silchar- 788010, Assam** for the UG Engineering programs in whose case the period of accreditation in Tier I has expired on 30.06.2021.

2. The National Board of Accreditation (NBA) has decided that in all cases of UG Engineering programs which were accredited in Tier I/Tier II in January, 2013 document initially for a period of 3 years upto 30/06/2017, then were further accredited for a period of 3 years upto 30/06/2020 on the basis of Compliance Report, and were granted accreditation for the Academic Year 2020-21 i.e. up-to 30/06/2021 on the basis of Compliance Report submitted by the Institute due to Covid-19 pandemic situation, the programs will be considered for accreditation of one year for the Academic Year 2021-22 on the basis of the programs meeting the pre-qualifiers. The application may be submitted online on e-NBA portal by 31<sup>st</sup> December, 2021.
- 5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to National Institute of Technology Silchar, Cachar, Silchar- 788010, Assam as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.
